- 2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2011(Annex. II).
- The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
 - The School shall not deny admission to any child for lack of age proof, if such admission is sought subsequent to the extended period of ninety days for admission; and on the ground of religion, caste or race, place of birth or any of them.
- 4. The School shall ensure that: -
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in that school.
 - (ii) No child shall be subjected to physical punishment or mental harassment.
 - (iii) No child is required to pass any Board examination till the completion of elementary education.

- 8. No unrecognized classes shall run within the premises of the school or outside in the name of school.
- 9. The school buildings or other structures or the grounds shall not be used during the day or night for commercial or residential purposes, except for the purpose of residence of any employee of the school or for political or non-educational activity of any kind whatsoever.
- 10. The school shall be run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
- 11. The school shall not be run for profit to any individual, group or association of individuals or any other persons.
- 12. The accounts of the school shall be audited and certified by a Chartered Accountant and proper accounts statements shall be prepared as per rules. A copy each of the Statements of Accounts shall be sent to the Deputy Director Elementary Education Officer every year.
